




V. Powers of the president.

VI. Powers of the Secretary.

The accounts can be opened in any bank for the convenience of trust and the accounts will be operated by the secretary until any changes made by the president


- ix. The accounts duly audited by Chartered Accountants will have to be presented to the General body. The accounting year is 31st march of every years and this is responsibility of secretary.

X. General Body Meeting:-


General body meeting will be once in a year i.e., after the The finalization and audit of accounts after 31st of march every year and within three months from that date and should be approved in General body.
